

**The RoomPlace® –Cast Your Vote to Win!
(the “Contest”)
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE WILL NOT INCREASE AN ENTRANT’S CHANCES OF WINNING. VOID WHEREVER PROHIBITED OR RESTRICTED BY LAW.

I. NAME OF SPONSOR

On or about November 6, 2020, the Sponsor will randomly select one potential winner from among all eligible entries received through a random drawing (the “Random Drawing”).

The winner will be notified by e-mail (if entered via Mail-In Entry) after the Random Drawing with instructions on how to claim their prize.
